3) IP Teams & Captains

4) <u>Blenheim Regional Conference</u>

K Collins will be attending. The two issues we would like brought up are:

i) That IP Travel revert to the original format, ie people book their own flights and NZ Bridge re-imburses them to their cap.

 ii) IP Travel cap for Invercargill be increased. Because of the geographical nature of Invercargill only Air New Zealand fly there, hence cheap competitive flights are not an option, nor is taking a day off work to drive to and from Dunedin a reasonable request. Currently a smart saver airfare is \$279 each way (return \$558), so something in this vicinity would be a fair and reasonable cap.

5) Balclutha Tournament

Lindsay Lawrence has agreed to be the director. A Stokes to send them 6 mugs for their raffle.
